Objectives and Investment Policy

The investment objective of the Fund is to provide capital growth.

The Fund will seek to do this by investing in:

- transferable securities;
- units in collective investment schemes;
- money market instruments;
- deposits;
- cash or near cash investments;
- warrants; and
- derivatives.

The Fund will have a diversified portfolio and invest in markets across the world.

There will be no emphasis placed on any particular economic, industrial or geographical sector.

In normal market conditions most of the Fund will be invested save for an amount of cash as is needed to be able to readily settle liabilities, which would normally be 10%. However, if markets are volatile or uncertain the investment adviser may hold a substantial part of the Fund in cash, deposits or money market instruments.

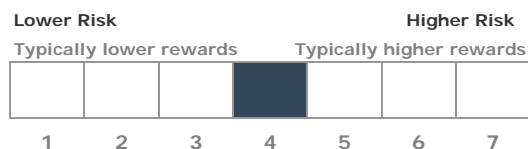
Derivatives will be used only for hedging purposes and not more than 5% in value of the property of the Fund will consist of warrants.

Fund selections and recommendations are made using a mix of quantitative and qualitative analysis. Analysts consider medium to long-term cumulative performance of funds (including ETFs) but also investigate discrete period returns and risk metrics. Fund managers passing filter tests are then met in order to gain an understanding of their investment process and current market positioning. Terms will be negotiated with any fund house chosen and thereafter due diligence is on-going through regular assessment of performance and update meetings.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

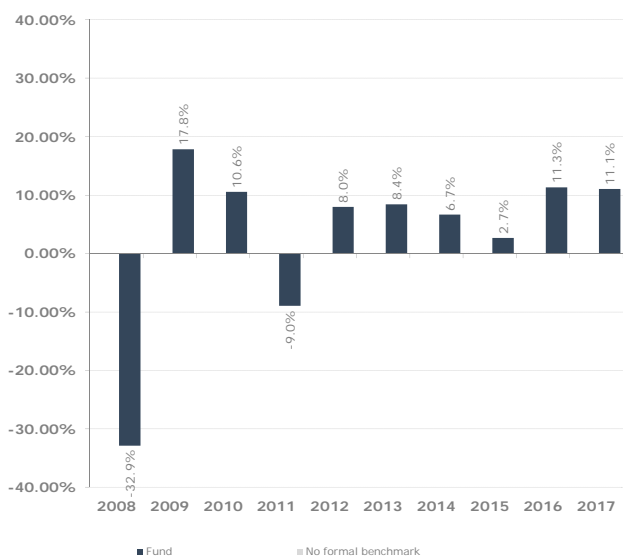
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
