Objectives and Investment Policy

The objective of the fund is to achieve long term capital growth.

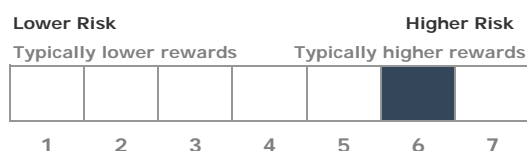
The Fund will invest predominantly in a diversified portfolio of Japanese equities listed on the local and international stock exchanges.

The Fund portfolio will not be restricted in the choice of company, either by market capitalisation size or industry. If considered appropriate, it may invest in other markets and in other assets including government and public securities, other debt instruments, other transferable securities, cash and near cash, deposits, and money market instruments. Derivative instruments may be used to manage exposure to risk, reduce cost, or for the generation of income.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 6 due to the volatility of the Fund price which sits in a range of between 15% and 25%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

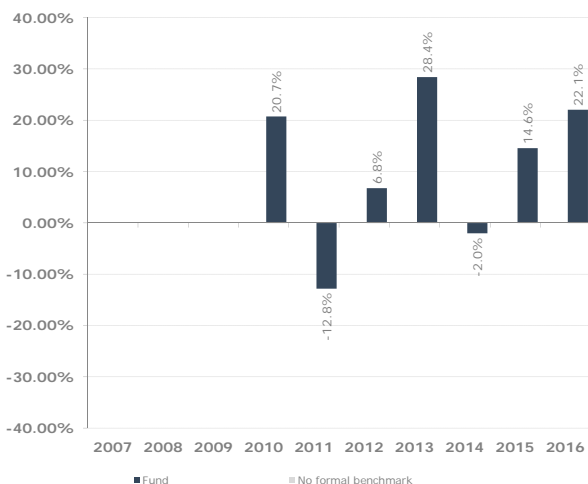
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
