Objectives and Investment Policy

The investment objective of the Fund is to provide both income and capital growth over the long term. The aim is to have a diversified portfolio and invest in various markets and assets across the world. There will be no emphasis placed on any particular economic, industrial or geographic sector.

The Fund will make the following types of investments:

- equity investments in companies;
- units in collective investment schemes (meaning other funds, or pooled investment vehicles); and
- bonds issued by companies or governments.

Other investments may be in:

- other types of transferable securities;
- money market instruments (such as bank deposits or short term debt instruments);
- deposits;
- warrants (such as options to buy bonds); and
- cash or other assets that have a similar characteristic to cash.

The Fund may also use derivatives or forward transactions for hedging purposes only. Derivatives are linked to the rise and fall in value of other assets, meaning their price comes from the value of that other asset.

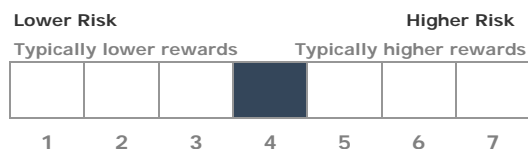
Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Fund selections and recommendations are made using a mix of quantitative and qualitative analysis. Analysts consider medium to long-term cumulative performance of funds (including ETFs) but also investigate discrete period returns and risk metrics. Fund managers passing filter tests are then met in order to gain an understanding of their investment process and current market positioning. Terms will be negotiated with any fund house chosen and thereafter due diligence is on-going through regular assessment of performance and update meetings.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of simulated data which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

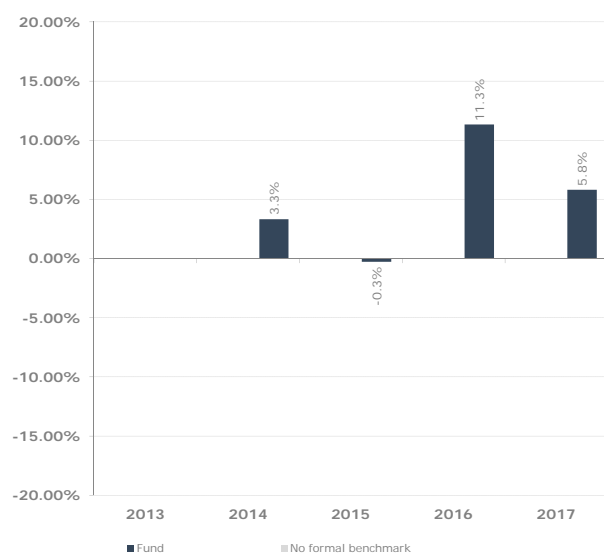
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
