### Objectives and Investment Policy

The investment objective of the Fund is to achieve long-term capital growth.

The Fund will seek to achieve its objective by investing in a well-diversified set of investments. The Fund will target an annual net return of inflation (measured against RPI) of +4-5% with lower volatility than equity markets over a rolling five year period and will target a 4-6% long-term tracking error to global capital markets.

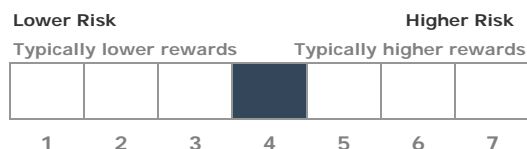
The Fund will hold a diversified portfolio, typically consisting of equities, fixed income, commodity related instruments and cash. Investments may be made directly, or in shares and/or units in collective investment schemes (including absolute return Funds, index Funds such as exchange traded Funds (ETFs) and actively managed Funds). Indirect exposure to commodities may be sought through investment in transferable securities, eligible index derivatives and collective investment schemes.

The Fund may use derivatives for investment purposes and for efficient portfolio management purposes. The Fund will use hedging strategies to reduce risk over the short term without materially altering its risk profile.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

- This Fund is allowed to use derivatives to achieve its objective. Derivatives can cause a Fund to become leveraged. - The Fund may use derivatives to reduce costs, overall risk and/or generate additional capital or income. This is known as Efficient Portfolio Management (EPM). When used for EPM purposes, there should not be an increase in the overall risk level of the Fund.
- Where derivative or structured product investments in the Fund may include a counterparty, there is a risk that the counterparty will not fulfil their obligation.

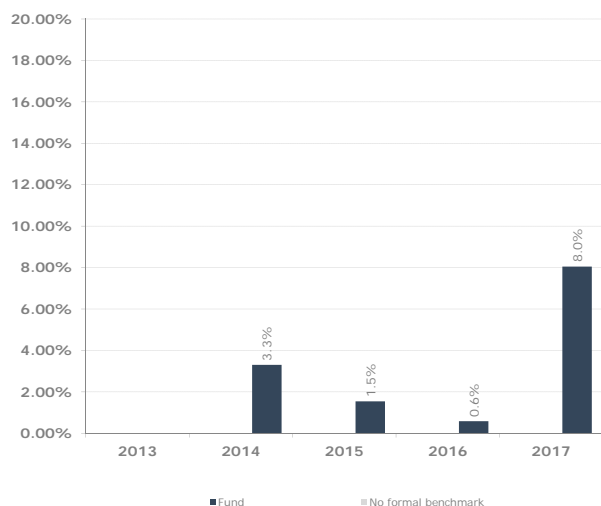
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
