### Objectives and Investment Policy

The Fund's objective is to provide capital growth over the longer term.

To achieve its objective, the Fund will be actively managed and primarily invested in a variety of collective investment schemes that will predominantly seek exposure mainly to UK and international equities and with some exposure to fixed income and alternative investments (including, but not limited to, commodities, convertible bond funds, UCITS long short funds, market neutral hedge funds and private equity) to provide a mix of growth assets.

The Fund may also invest in transferable securities, money market instruments, exchange traded funds, cash and cash deposits, as permitted in this Prospectus.

The use of derivatives and hedging transactions is only permitted in connection with the efficient portfolio management of the Fund (including hedging).

The Fund has the power to use derivatives and forward transactions for investment purposes but this power would not be exercised without providing Shareholders with at least 60 days' advance notice. Should the ACD and the Investment Adviser decide to invest in derivatives and forward transactions for investment purposes, the net asset value of the Fund could at times be volatile (in the absence of compensating investment techniques) and the risk profile of the Fund could therefore be increased. However, it is the ACD's intention that in those circumstances, the Fund, owing to its portfolio composition or the portfolio management techniques used, would not have volatility over and above the general market volatility of the markets of its underlying investments.

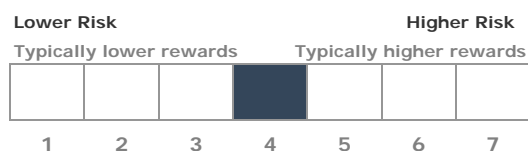
Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Fund selections and recommendations are made using a mix of quantitative and qualitative analysis. Analysts consider medium to long-term cumulative performance of funds (including ETFs) but also investigate discrete period returns and risk metrics. Fund managers passing filter tests are then met in order to gain an understanding of their investment process and current market positioning. Terms will be negotiated with any fund house chosen and thereafter due diligence is on-going through regular assessment of performance and update meetings.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

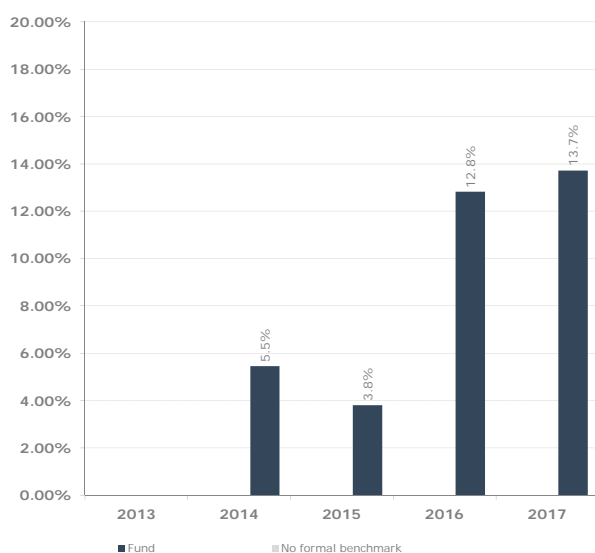
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
