Objectives and Investment Policy

The Fund's objective is to provide capital growth over the longer term.

The Fund will be actively managed and will seek to achieve the investment objective by primarily investing in a variety of collective investment schemes.

The Fund will predominantly seek exposure to mainly UK and international equities and will also have exposure to fixed income investments and alternative investments.

The use of derivatives and time weighted transactions is only permitted within efficient portfolio management of the Fund.

The Fund may also invest in:

- transferable securities;
- money market instruments;
- · exchange traded funds; and
- · cash and cash deposits.

The use of derivatives and hedging transactions is only permitted in connection with the efficient portfolio management of the Fund.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Fund selections and recommendations are made using a mix of quantitative and qualitative analysis. Analysts consider medium to long-term cumulative performance of funds (including ETFs) but also investigate discrete period returns and risk metrics. Fund managers passing filter tests are then met in order to gain an understanding of their investment process and current market positioning. Terms will be negotiated with any fund house chosen and thereafter due diligence is on-going through regular assessment of performance and update meetings.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.


