Objectives and Investment Policy

The objective of the Fund is to generate income as well as moderate long term appreciation through the active management of a globally diversified portfolio of investments.

The Fund will provide investors with an actively managed diversified portfolio with performance measured against UBS AG, London Branch's proprietary 'Global Yield' benchmark, one of a range of UBS created multi-asset class benchmarks specifically designed for the private investor.

The Fund will predominantly invest in UK and global bonds with a smaller allocation to UK and global equities.

In normal circumstances, the Fund will primarily use collective investment vehicles. At the Investment Adviser's discretion, the Fund may also invest in other transferable securities, money market instruments, cash and near cash.

The Fund may be invested more heavily than usual in government and public securities while the Investment Adviser is carrying out due diligence on managers of collective investment vehicles in which the Fund may invest.

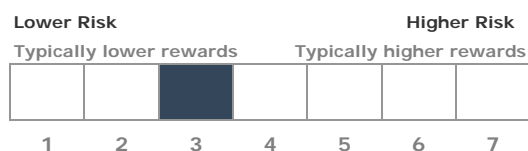
Fund selections and recommendations are made using a mix of quantitative and qualitative analysis. Analysts consider medium to long-term cumulative performance of funds (including ETFs) but also investigate discrete period returns and risk metrics. Fund managers passing filter tests are then met in order to gain an understanding of their investment process and current market positioning. Terms will be negotiated with any fund house chosen and thereafter due diligence is on-going through regular assessment of performance and update meetings.

The fund is monitored against the benchmark specified, within a tolerance level of 5% (above or below). Any deviation from that tolerance level will be reviewed and action taken as applicable.

The base currency of the Fund is pounds sterling.

Income arising from the fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 3 due to the volatility of the Fund price which sits in a range of between 2% and 5%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

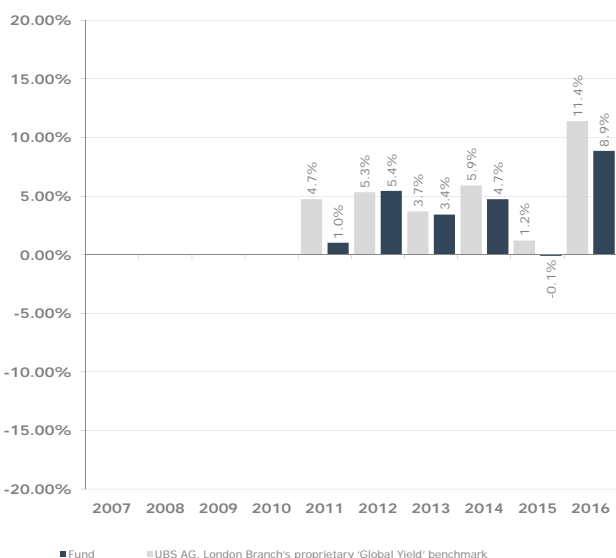
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
