This Fund is managed by Thesis Unit Trust Management Limited.

### Objectives and Investment Policy

The investment objective of the fund is to provide long term capital growth from a portfolio of investments.

The fund will achieve the investment objective by mainly investing in UK equities which have middle to large levels of capitalisation to maximise potential returns.

The fund may invest in:

- securities;
- money market instruments;
- deposits; and
- warrants;
- units in collective investment schemes.

Fund selections and recommendations are made using a mix of quantitative and qualitative analysis. Analysts consider medium to long-term cumulative performance of funds (including ETFs) but also investigate discrete period returns and risk metrics. Fund managers passing filter tests are then met in order to gain an understanding of their investment process and current market positioning. Terms will be negotiated with any fund house chosen and thereafter due diligence is on-going through regular assessment of performance and update meetings.

The base currency of the Fund is pounds sterling.

Income arising from the fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

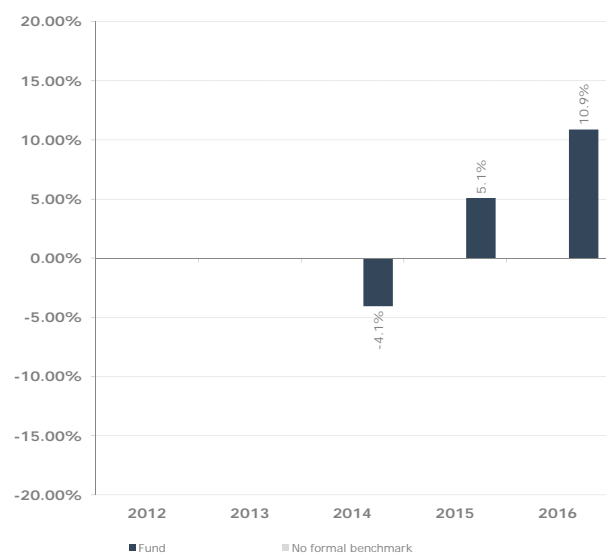
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
