Objectives and Investment Policy

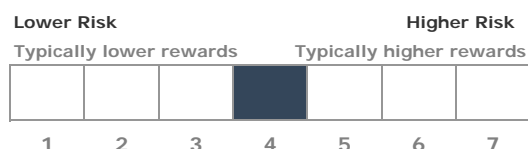
The investment objective of the Fund is to achieve growth in capital and income.

Growth in terms of income and capital gains will be sought by constructing an international spread of investments, by investing in any country and in any economic sector of the world. The Fund may invest in transferable securities, money market instruments, deposits and units in collective investment schemes (regulated and unregulated).

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can redeem shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

- This Fund is allowed to use derivatives to achieve its objective. Derivatives can cause a Fund to become leveraged. 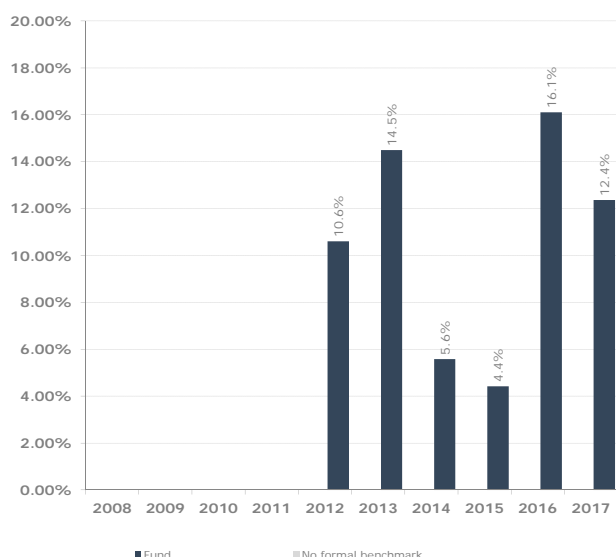
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
