Objectives and Investment Policy

The investment objective of the Company is to achieve long term capital and income growth.

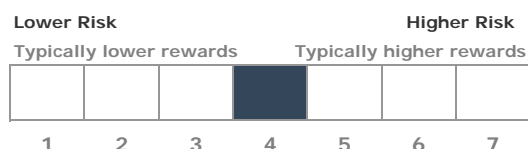
The Company will pursue its investment objective by gaining exposure to a portfolio of equities, bonds and cash or near cash, either through direct investment or through investment in other collective investment schemes. The Company may, at the Investment Adviser's discretion, also invest in other transferable securities, money market instruments, deposits and warrants.

The Company may use derivatives for the purposes of Efficient Portfolio Management (including hedging).

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can redeem shares on demand when the scheme prices 14th and the last Business Day of each calendar month at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of simulated data which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

- The Fund may use derivatives to reduce costs, overall risk and/or generate additional capital or income. This is known as Efficient Portfolio Management (EPM). When used for EPM purposes, there should not be an increase in the overall risk level of the Fund.
- Where derivative or structured product investments in the Fund may include a counterparty, there is a risk that the counterparty will not fulfil their obligation.

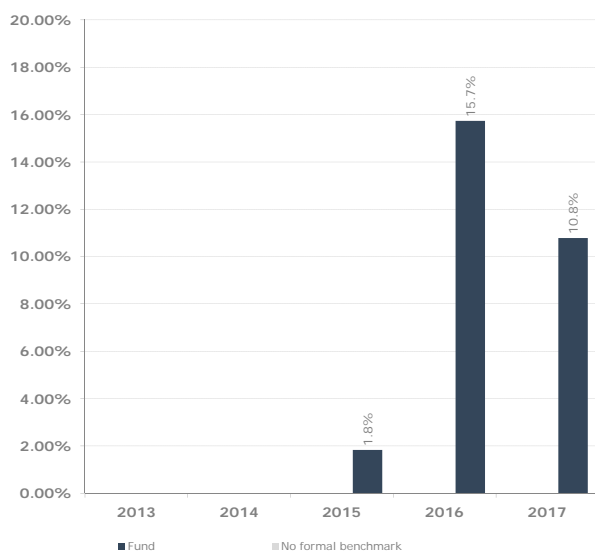
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
