### Objectives and Investment Policy

The investment objective of the Fund is to achieve long term growth in capital and income.

The Fund will pursue its investment objective by constructing an international spread of investments through investing in any country and in any economic sector of the world.

The Fund will invest mainly in units in collective investment schemes (regulated and unregulated) and may also invest in transferable securities, money market instruments, derivatives and deposits.

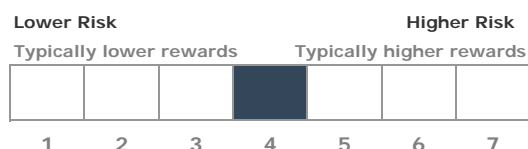
There may be occasions when the Investment Adviser chooses to hold a significant proportion of the Fund's assets in cash and near cash instruments.

Derivatives may be used for both investment purposes and Efficient Portfolio Management in accordance with the FCA Rules.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can redeem shares on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

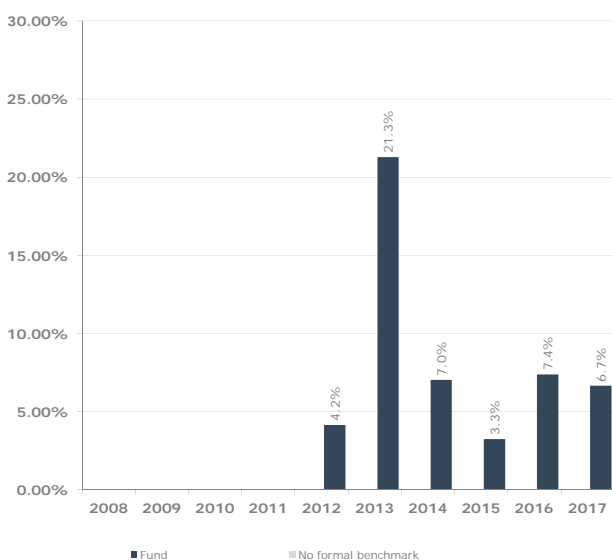
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
