Objectives and Investment Policy

The objective of the Fund is to provide a balance between long-term capital growth and income. The Manager's policy is to achieve this objective by investing in permitted investments for a UCITS scheme. The Fund may be invested in transferable securities in any sector both geographically and by industry, money market instruments, deposits, units in collective investment schemes, derivative instruments and forward transactions as appropriate.

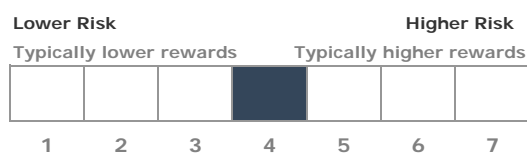
The Manager may enter into derivative transactions but only for the purposes of hedging and the use of derivatives will not affect the risk profile of the Fund. The Manager does not envisage entering into hedging transactions to a major extent.

Fund selections and recommendations are made using a mix of quantitative and qualitative analysis. Analysts consider medium to long-term cumulative performance of funds (including ETFs) but also investigate discrete period returns and risk metrics. Fund managers passing filter tests are then assessed in order to gain an understanding of their investment process and current market positioning. Terms will be negotiated with any fund house chosen and thereafter due diligence is on-going through regular assessment of performance and update meetings.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices on the fourteenth day and on the last business day of each month at 10.00am.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of simulated data which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.
