Objectives and Investment Policy

The objective of the Scheme is to achieve capital growth, net of fees, over a rolling 5 year period.

The Scheme will invest in a global portfolio, in any or all economic sectors, which will typically comprise of equities (at least 70%). The remainder of the Scheme Property may be invested in fixed income securities (which may include government and public securities) and transferable securities, cash, and money market instruments. The composition of the Scheme Property as between equities, fixed income and other asset classes will vary over time depending on the Investment Manager's assessment of market conditions as well as the economic environment. The exposure to equities may fall below 70% during difficult markets. The above exposure may be gained directly or through the use of collective investment vehicles (including investment trusts and exchange traded vehicles) which may include collective investment vehicles managed by the Manager or its associates or the Investment Manager or its associates. Derivatives may be used for the purpose of hedging, although use is expected to be limited. The Investment Manager will actively manage the Scheme. This means the Investment Manager actively makes decisions about how to invest the Scheme Property (and which investments to buy and sell) instead of simply following a market index.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units, and reinvested in the case of accumulation units. Investors can buy and sell units on demand when the scheme prices daily at 12 midday.


