### Objectives and Investment Policy

The objective of the Scheme is to achieve capital growth over the long term (over a rolling 5 year period), net of fees.

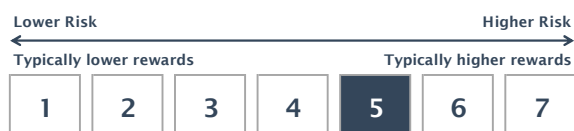
Between 35% to 60% of the Scheme's assets will be invested in UK companies (defined as those which are domiciled, incorporated or have a significant exposure to the UK) which are constituents of the FTSE-All-Share Index. Between 35% and 60% of the Scheme's assets will be invested in overseas equities. Investment trusts and collective investment schemes (including those managed or operated by the Manager or its associates) may be used to achieve some or all of the overseas and smaller companies' exposure. Up to 30% of the Scheme's assets may be invested in bonds, cash, near cash and money market instruments. The weightings in particular asset classes will reflect market conditions. At times, during times of market volatility, the Scheme may hold a significant amount in cash.

The Investment Manager will actively manage the Scheme. This means that the Investment Manager actively makes decisions about how to invest the Scheme property (and which investments to buy and sell) instead of simply following a market index.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units, and reinvested in the case of accumulation units. Investors can buy and sell units on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

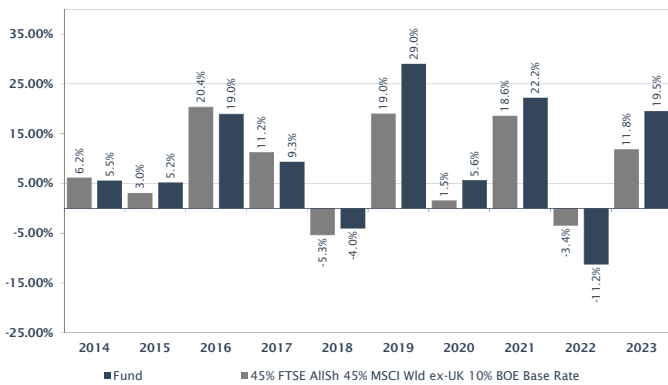
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
