### Objectives and Investment Policy

The aim of the Fund is to provide capital growth, that is, to increase the value of your investment, over a period of at least 7 years.

It will invest at least 70% in other collective investment schemes, investment trusts and exchange traded funds (collectively "Investment Funds"). This could include other Investment Funds managed by the Authorised Corporate Director or the Investment Manager.

Through these Investment Funds, the Fund will have exposure to at least 75% in shares in companies globally, the remainder will be made up of other eligible assets, such as bonds (investment grade and sub-investment grade), property and cash.

The Fund may also hold up to 30% directly in shares in companies, bonds (which are loans typically issued by companies and governments) graded investment grade and above, money market instruments (shorter term loans), cash and structured products.

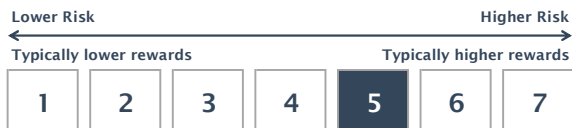
The Fund may use derivatives (instruments whose returns are linked to another asset, market or other variable factor), or forward transactions to manage currency exposure (hedging) for efficient portfolio management. Other Investment Funds purchased may have the ability to use derivatives to varying degrees.

The Fund will be actively managed, which means the Investment Manager decides which investments to buy and sell and when.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

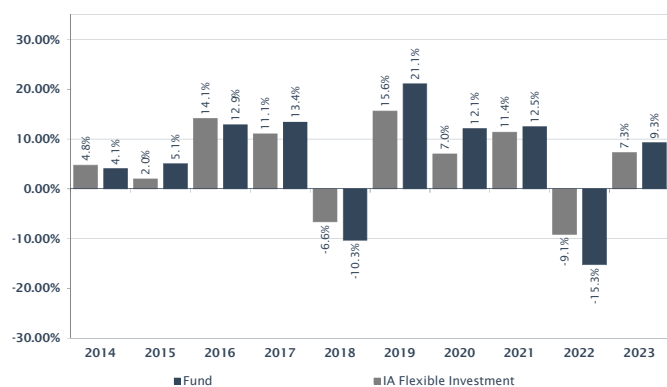
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
