Objectives and Investment Policy

To generate growth over the long term (5 years or more) by investing in a diversified portfolio of equities (company shares) and bonds (loans to governments or companies).

The fund invests at least 70% in global equities, corporate investment grade bonds and government bonds issued anywhere in the world. The fund may hold other securities and asset classes (e.g. supranational and other types of bonds and listed real estate) issued anywhere in the world. The fund may also invest in other funds (including those managed by the Manager, or its associates, or the investment manager or their associates), money-market instruments and cash. The management team use their discretion (active management – which means the Investment Manager will actively make decisions about how to invest the Scheme Property and which investments to buy and sell instead of simply following a market index) to identify holdings based on an analysis of global economic and market conditions (for example, interest rates and inflation) and analysis of a company's prospects and creditworthiness compared to that of the market. They focus on selecting companies and bonds and ensuring that the allocation of assets meets the fund's objectives.

The fund may use derivatives to reduce risk, to reduce cost and/or generate additional income or growth consistent with the risk profile of the fund (often referred to as "Efficient Portfolio Management"). Derivative usage in the fund is expected to be very limited. Where derivatives are used, this would mainly be to manage expected changes in interest rates, companies share prices, currencies or creditworthiness of corporations or governments. The fund may also invest in other funds which may use derivatives extensively although these investments shall be in line with fund's overall risk profile.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

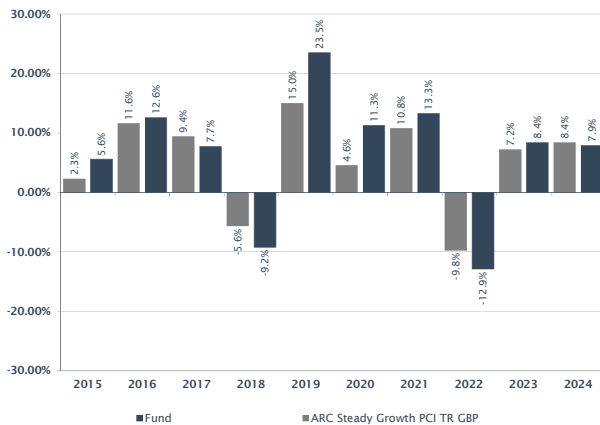
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
