#### **Objectives and Investment Policy**

The Fund's objective is to achieve growth in value (through a combination of capital growth and income), in GBP terms, with a target return of the UK Consumer Prices Index (CPI) plus 3.5%, net of fees, over rolling 7 year periods. Capital is at risk and there is no guarantee that this return will be achieved over this specific period, or any other period.

The Investment Managers adopt a flexible investment strategy and may invest in some or all sectors in some or all world markets, in order to take advantage of economic opportunities worldwide. The Fund will typically allocate between 40% - 90% to equities. The Fund may also invest in fixed income (including both corporate and government bonds), money market instruments, warrants, deposits, cash and near cash. Investment in gold and commodities may be made through permitted investments such as collective investment vehicles.

The Fund may also invest in alternative strategies via permitted investments such as authorised and unregulated collective investment vehicles, in accordance with the FCA Rules. An alternative strategy is a financial asset which does not fall into one of the conventional investment categories such as equities, bonds and cash. Alternative strategies are designed to achieve risk-adjusted returns which have a lower correlation to major indices and markets. The composition of the Scheme Property as between equities and other asset classes will vary over time, in response to the Investment Managers' views of the economic and market environment. In addition, the exposure to equities may fall below 40% during difficult market conditions.

Typically, more than 50% (and at times up to 100%) of the above exposure will be gained through the use of collective investment vehicles. Collective investment vehicles may be managed by the Manager, the Investment Managers or an associate of the Manager or the Investment Managers. Derivatives may be used for Efficient Portfolio Management, although use is expected to be limited. The Manager has appointed multiple Investment Managers with different investment styles to achieve the investment objective. Allocations to the Investment Managers are subject to change in order to meet the Fund's investment objective and further details regarding the allocations are available upon request from the Manager.

The Fund uses CPI plus 3.5% as a target benchmark. CPI has been selected as a performance target because it is a key measure of consumer inflation in the United Kingdom. The Fund aims to deliver positive returns plus 3.5% in excess of CPI, over rolling 7 year periods. CPI is therefore an appropriate target for the Fund.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units, and reinvested in the case of accumulation units. Investors can buy and sell units on demand when the scheme prices daily at 12 midday.
